Waterfront

- No fueling of gas tanks at docks!
- All gas cans and outboard motors to be stored in the gas shed and **Not** in the club basement.
- No boats tied overnight to any of the four outer floats unless approved by the board of trustees
- End float is used for **Loading and Unloading Only.**
- Washing down of boats to be done on side docks only.
- Boats tied to the four outer end docks should not be left unattended unless approved by the board of trustees.
- Please try to reduce your turn around time on the dock, especially on holidays and weekends
- All dinghies 10 feet or less to be tied to dinghy docks. Only one dinghy allowed per membership.
- All dinghies must display current dinghy sticker.
- All dinghies must have a minimum 10 foot painter line which should be attached to the bow. on the line **No Chains or Locks on Dinghy Lines Allowed.**
- Dinghies with motors are to be tied to the easterly dinghy dock(s) only.
- All Sunfish & Opti's to be stored in the boat racks and not on the beach or marsh grass.
- No boats of any type are to be pulled up and stored on the beach or grass by the picnic tables.
- Children 12 and under **Must** wear lifejackets while on the docks.
- All skiffs (15 feet or less) assigned spots on the south facing docks are to be tied up stern to with bow anchor or mushroom. The first twelve floats have been reserved for these boats.
- All requests for skiff space should be made in writing to the WBYC Board of Trustees @ P.O. Box 3434, Waquoit, MA. 02536
 - All skiff lines are for the assigned member only
 - All assigned skiff spots are to have a boat on them and be actively using assigned spot. If the assigned member is not going use their spot they can ask the board for a leave of one year, during which the spot will be temperedly loaned to the next member on the list. Otherwise skiff spot will be forfeited to next member.

Clubhouse & Grounds

- Members must accompany guests at all times while on club grounds.

- Parking permits for members' cars should be current and hung from the rearview mirror on the front windshield.

- All guests' cars should have the member's name displayed on the dash at all times while parked in the lot.

- When staying overnight on your boat, or cruising for an extended period, please park on the right or left side of the lot or by the fence. Please double up your cars whenever possible.

- Waquoit Bay Yacht Club may be used by senior members for private functions only upon prior approval by the WBYC board. Requests are required to be made by completion and submission of the request form which is available on the web site (www.waquoitbayyachtclub.com), click on the Social events link. The requested date may not interfere with a club function (at the determination of the Social Committee Chair).

- The WBYC board will not approve requests for private functions during the months of July & August.

- Club facilities are not to be used for any type of commercial enterprise.
